#### IV. AAA Vote on Constitution

<u>Michael:</u> We are voting on the Constitution, it passed the Senate with the stipulation that I did two jumping jacks, which I did. It now needs to pass with  $\frac{2}{3}$  of voting members.

Motion Clearly passes, the New Constitution will henceforth be incorporated.

# V. Organizational Review

Zane: One of the ideas I had over break was to dig in and think about the problems of ASCMC, I created a large Google Doc for this. Basically, I claim that it is a good goal to find the problems of ASCMC, we need to craft solutions, but first denote the problems. It would be good for us as a groupsenate and exec- to find where we are lacking. Review ASCMC as a whole, figure out the shortcomings, and then propose solutions. The proposal is to create a working group or team. This group will not be amending the constitution, but will be investigative and advisory. Especially with the senate, there is a tendency that once exec members or upperclassmen promote something, that is how it goes. It is important that we empower the underclassmen in the Senate and within ASCMC. Once we form the team, they will investigate- look at the constitution, the mission, etc. I looked at CPB, they really emphasize that they are mission driven; however, I am unsure of what the ASCMC mission is. The structure is an equal number of officers and senators. Once the review team has finished its report, it will present it to the Senate, Exec, and the rest of the student body. I hope that you all can contribute to the areas of concern section. We all have unique perspectives of the things that ASCMC does right and wrong. We want to brainstorm as much as possible. I've also been working on creating a template



for interviewing students who are not a part of ASCMC or have not been involved with it. This is just a proposal, but I thought it would be a helpful process to initiate and aid discussion and to help with solutions.

<u>Katherine:</u> We do have to vote on this idea, along with the creation of the committee. This could become a tradition to occur every two to three years.

<u>Jon Joey</u>: In terms of structure and the President's input, they would check in with the chair and they would not sit on the board?

<u>Zane</u>: Yes, the president wouldn't sit on the board. The intention is that people will contact Sam or Katherine and they can divert them to the committee.

Katherine: This committee is until the end of our term, and not imposed on the next one.

<u>Michael</u>: Looking at the timeline, any changes that are done due to the findings of this committee would not take form until the 22-23 board? This is mainly a way to stir up conversation? Under this proposal would amendments be discouraged?

Zane: There is nothing that would expressly prohibit our board or the next board from passing such changes and amendments. Propose a menu of recommendations, so that Senators don't have to rely on past dates. Amendments would be neither encouraged nor discouraged.

<u>Sam Bogen</u>: In theory we can ratify an amendment whenever. How could we get this timeline done before turnover, or will it be collaborative between us and the next board.

<u>Zane</u>: This may fall through until next term, because the president and EVP appoints the members, the new president and EVP could appoint such members. This might be more helpful if it spans two administrations.

Katherine: We are essentially doing an org psych review of ASCMC for us and the future boards.

<u>Sam B</u>: Looking at the doc, is there enough time to go through all the areas of concern?

<u>Zane</u>: I think it depends on the people appointed on the committee, if you find the right group, it can absolutely be accomplished.

<u>Cindy</u>: Basically, I think this group would help from things getting lost during turnover, it is a record of things. Even if it does not get done right away, it is recorded and can help out future boards.

If it doesn't pass at all, rewrite or give up. Anybody can propose an amendment!

Nicole: How are you going to distribute and collect this form?

<u>Michael</u>: This is just a Doc, that way people can collaborate. I will share with the Exec board, and it may be included in the Senate Email tomorrow.

<u>Sam Bogen</u>: If it is within ASCMC, you can do it within the Constitution, Adhoc for Exec would be with president, Adhoc for Senate would be EVP



<u>Katherine</u>: You can also reach out to DOS and they can create a committee. We will be talking about room retention. Essentially she wants pros and cons.

#### Pros for keeping room retention:

Allows Sophomores to live in NQ People don't have to invest in pricy storage units over the summer Having the same room would make me feel more at home at college

<u>Demond</u>: Only juniors should have room retention, sophomores should have to go through the AK gauntlet

<u>Sam</u>: No matter what happens, can we allow folks at AK retain? I don't see why that would be a con or pro? It would help people who want to live on campus

#### Cons for keeping room retention:

<u>Christina</u>: Freshman shouldn't have room retention to prevent incompatible roommate pairings <u>Sam</u>: RA meeting- they don't like it because certain teams monopolize certain suites. They retain it and switch around the rooms. A lot of the time sport teams have a suite together, but they shouldn't have the same suite year after year after year.

<u>Katherine</u>: We should mention AK, Juniors have been promised good times and living on campus. Maybe all room retention should be banned for sophomores so that the sophomores that don't retain don't just get sent to AK. We are still over enrolled, it will be 3 years until we are normal sized again.
