# IV. Budget Update

Desmond: Had budget freeze! Not all expenses have been reconciled BUT currently has 20,000-2,500 (stoles) = 17,500. There was an issue with credit card charges that is putting us in the negatives, but will be reconciled soon. I strongly suggest lending sports/clubs more of a hand than Sam can alone. Time to replenish Sam's discretionary, but Sam should provide a list of things he wants to fund, and we can collaborate VIA SLACK, not during meeting time.

Gio: What is the general fund?

Desmond: Senate has 15,000 that it can spend on whatever. Executive board has a ton of different discretionaries, dorms funding, clubs funding, & events funding. General fund is administered by majority vote of the executive board. Typically it is at 10,000, we are currently gave 2,500 to stoles. Budget freeze deposits money into general fund

Zane: What if the general fund runs out?

Desmond: Rainy day fund has \$100,000 in it! This rolls over into next year. We also get an endowment return x-thousand dollars depending on returns from the previous year. This endowment money goes into the general fund, but doesnt get used immediately. General fund (and events) can be used to purchase alcohol. But, student fees can't be used on alcohol. This is why pirate party must sell T-shirts to fund alcohol. Alcohol ledger dictates that no student fees can be spent on alcohol.

Wolfy: Getting 20,000 back from dorms and clubs, so what was the amount of money granted originally?



Desmond: Clubs and Dorms have ~\$150,000, class discretionaries vary. Sam has discretionary, So does Zane, Josh, Kirby, & Nisha.

Josh: When do discretionaries reset?

Desmond: Everything expires june 30th, and goes over into roll over funds.

#### V. ASCMC Wage Discussion

Amari: Staff get paid 14 dollars an hour, but minimum wage in LA county was increased to 15/hour as of January 1st 2022. I think we should honor the LA county minimum wage if we want to have people working for ASCMC. I don't think it is controversial.

Desmond: We are bound to a different legal standing because we are a "small business" and thus we have a smaller minimum wage (city of claremont, not greater CA). I dont think it's possible to change for this next three weeks, but we can definitely change to 15/hour for NEXT round of events staff/staff in general. This can be a slack vote.
