IV. PiratePalooza Debrief

Chris: went well overall, there were hurdles along the way with DOS but that will be discussed within conversation with MK outlining how their demands were stressful. Sam: No one was manning the food table, Me and Zane had to work on it for over an hour, and we had two students cover us when no one was there and they were working above and beyond. Motion to pay them!

Desmond: There's no strict wording, but it is important that we stick to this core value of ours. we should also have a conversation about how we can streamline this later—relying on a broad group of people is less secure when it comes to numbers

Zane: There were some people who were not there for set up or clean up, which ultimately is not fair for people who were there, like Chris, who worked 10+ hours.

Desmond: We should try to work and schedule this farther in advance as well as last minute scheduling will lead to last minute cancellations.

V. Orientation Programming

Sam: We want to roughly gauge who is moving in early, who wants to, and what we ultimately want to do.

Josh: who would want to move in early. (4 people)

Sam: Aug 21 is freshman move in, the move in for y'all would likely be the 16th.

Chris: probably a day or two before the freshmen move in .

Josh: Two seems like a lot. Why would we need to get there before orientation?

Sam: we tabled during the in-n-out lunch and got to spread the word significantly.

Amari: The people who are already here can do the whole tabling thing, it seems odd to have them sit in their rooms for a long while, particularly as everyone goes on woa. We can then have people move in after WOA.

Kimi: That's how it was for me, and so i think that would be a good idea, and we can also have a puppy day with priceless pets

Desmond: we can also make it a part of regular orientation



Chris: We can also, because water party is gone, nave something for the freshmen in the bubble, marks basement, or somewhere else.

Josh: doing something outside seems ideal due to the beginning of the year covid concerns. Sam will be here doing RA things, Desmond will be here, Maeve will be FYG and working on mental health initiatives during orientation, Zane will be here, Nicole and Tori also FYGS.

Kirby: I remember going to the first ASCMC meeting (Senate) and there were so many people there that they were sitting on the ground. How will we work to retain these numbers?

Zane: We can work on how we do attendance – sending notifications when people are about to miss their third senate in a row. In some way though, the fall off is very organic. The senate chairs themselves can also work to retain at least the committee members within the senate.

Kimi: Can we incentivize senate by allowing people to join various groups mid year?

Josh: that's dependant on chairs

Aara: when talking about ASCMC, we should also talk about the committees because I didn't know what they were and there wasn't much talk on those before apps were due.

Chris: We can also have senate snack and incentivize people to show up through food.

Josh: Cindy and Sam both mentioned that - since we don't have snack on friday, maybe then?

Gio: I am unsure how to make it more appealing – it does feel like a whirlwind. It felt very procedural and not explained very well, I didn't have a solid idea of what was going on.

Aara: Can the time be changed?

Zane: It is moveable, it is currently at this time because of the When2Meet.

Kirby: Choosing a time that people are already out and not studying can be good.

(unanimous: 7:30 is a good time)

Josh: in terms of orientation planning, we can also have the socials again (boba for FLGI, 1Gen, ect).



Sam: Having it early ensures that people will stay, and also make sure you have speakers so that people can STAY

Maeve: I spoke with Jess about a potential mental health + advocates event that can be held.

Amari: There were a bunch of different groups who came (via zoom) and had an open forum for people to figure out what these groups were and ask questions. It could be valuable to have this for ASCMC with mandatory attendance.

Kirby: Maybe this can be a mental health collaboration, but we should also show that we are available as support systems for the student body early on.

Kimi: I really like that idea.

Gio: Should we also introduce what exec is to the first years as well?

Josh: Yeah, we can do that.
