## Cindy: Amendment passes

Sobe: For closed minutes: what will happen to them?

Sobe: How does DOS define class? What about Mid-Year grads?
Desmond: It's different for each scenario. It depends on which semester they start.
Jon Joey: I'm kind of interested in section 2.03 K , I think we should revise this. If I want to give myself a shot for these positions, I have to put my study abroad plans on the side. Specifically for DNI, I'm not understanding why we are including more barriers?

Sam: Here's my thing on each of those 3: CPO has to be on existing meetings. DNI was the last one I had difficulty on, it's very in person based, the DNI chair needs to be there for affinity group events. Is online meetings okay? Yes but end of the semester events are more difficult.
