

V. KSPC Budget Request

Desmond: No KSPC representative present. I can give a brief, the motion will take place next week. Basically, KSPC does a music festival every year. A 5c radio. Now they want to be able to pay student djs. They want \$800 for the student musicians they want to compensate. They wanted another \$3,000 for international artists. There's no revenue because they aren't selling tickets. \$100 for a 30 minute set. \$50 for a 15 minute set. Seems like a lot of money, more than a licensed psychiatrist. Possibly convince her to spread the cost to the other colleges, or lower the amount we are paying the student djs.

Katherine: Do you know how much money there is left in the general fund this year?

Desmond: allocation wise, there is about \$10,000. No other colleges are participating in paying the student djs. We might want to have this conversation with the KSPC representative present. KSPC is a 5C club, and as a commercial radio station they might have some commercial revenue. ASPC houses their fund.

Katherine: Straw poll to lower the student DJ pay

Results: 7 people want to lower, 2 people said keep it the same, one person abstained

VI. Graduation Stoles Funding

Katherine: This conversation is going to be put on slack

Desmond: Senior class stoles will be made for everyone. An equity issue. Desmond promised Grace already. Could be the general fund or senate. Either way, the \$5,000 should be given for those.

Cindy: we should make this a line item in the budget if we want to continue this

Katherine: Why does the school not pay for this

Desmond: For the moment, I'm going along with DOS, but we should talk to them about in the future having the school pay for those along with the cap and gown.

VII. Orientation Programming

Katherine: I want ASCMC to be very present during orientation. We are welcoming the class of 2025 and 2024. Class of 2025 is going to move in, do WOA for two days and come back and join 2024 to do orientation. I already got the go ahead from DOS for some exec members to move in early. People need to volunteer. What should we present? Open up the conversation>

Amari: How early?

Katherine: August 26, earliest would be Aug 10. Anywhere from aug 10 to aug 22.



Theo: When i was talking to Devon and Vince, and everyone, they were talking about how we have an opportunity to shape CMC culture to make it more inclusive. It would be important to have more diversity and inclusion stuff to present at orientation. I plan on talking to Vince about what we can do in that regard.

Cindy: Basically, during orientation, ASCMC gives a presentation about what ASCMC is. Only some first years come. If we can do some ASCMC designed t-shirts or an event that all the first years come to. Katherine: Essentially, Devon says that we come up with the programming and we can say who wants to move in early and get keys and we can come up with any programming we want and likely our event would compete with another event. I can also try to make a time slot that is dedicated to ASCMC.

Maybe two events- one with 24 and one with 25

Amadeo: If we don't want to compete with others, a food or meal thing would be our best bet. I could whip out the grill masters. Stop by, put a face to the name. Maybe a field day on parents with spikeball, volleyball, etc with gear so people come and meet us.

Katherine: Gear is 100% definitely. I want to be like here, welcome, free stuff

Nisha: I wanted to go back to theo's point. The D & I orientation event we had was dialogue matters. There are quite a few issues with how that ran and with lots of criticisms. Theo, I am happy to help with perspectives. Something that is missing is mental health help. We need to have something to show the steps available for mental health help.

Katherine: Something we can talk about is the vision of the board. Anti-racism, mental health for students, and the funds. Going back to our core values will be important in orientation and sets the narrative for the school year. Theo you should definitely work with Nisha

Sam: From the 26-28 before classes start would be the sex, drugs, alcohol education would be there. Maybe add a required mental health aspect. 25 doesnt have to do course registration, so they'll have more time to focus on this stuff.

Katherine: Maybe we move in on the 21st??

IX. Open Forum

Amadeo: I have a budget request. This will be literally 2 minutes. Welcome to the show. Bubble stuffskis. Caroline and I spent the weekend in the bubble organizing the stuff. We are super stoked and hoping to put some big shelving units in the shed. Two heavy shelving units. Cord wraps. A basic tool kit. A bucket. 2 Battery lights for inside of the shelves.

Sam: I'm not sure if there's a socket set with the drill

Amadeo: It does, there is a middle of the road thing, we could get a better one, I would not be opposed Katherine: How can we make the bubble more of a student space

Amadeo: the bubble was a best kept secret, I think it has the potential to be a hub x reading room hybrid. DOS had planned on using it as a classroom kinda. It is a cool workspace and work station. You can reserve the conference room through the storyhouse. To answer your question, one of the purposes of organizing the shed is to organize the bubble as well so we can open it up to students

Cindy: there is a formal agreement between ASCMC and the art council. The bubble is for the art council. Art council and ASCMC own the bubble but ASCMC can't take it over. ASCMC should speak with the art council so we don't overstep. I can find the agreement.



Amadeo: DOS might be able to overstep, if they want to use it as a classroom area. I think it's important that we talk to the Art council. My total is around \$700, with the intent to spend \$500 with wiggle room.

Caroline and Amadeo are put in the wait room for the vote.

X. KSPC Budget Request

Hanna: The budget is a little changed. KSPC is the student run radio station for the 5cs. We have been wanting to hold a virtual concert for anyone to join on May 1st. We originally wanted to do student artists and an international artist. But because of the timeframe we have now, we decided to focus on student artists. We contacted Pomona for money, and have reached out to other schools. But the request has lowered \$200-\$300. We are taking \$500 from KSPC's budget, and the money we have raised from Pomona. We need the funds to compensate the artists for showing their original art. \$50-\$100 per band or artist

Sam: could you repeat the total amounts

Hanna: we are requesting \$250-\$300 dollars from you guys.

Amadeo: How do you decide how you are splitting the artists

Hanna: most people who filled out to perform is from pomona, and a couple from the other schools except from CMC, but we were hoping to have you guys help us reach out to find a CMC artist

Desmond: Quantum would be a great resource

Amadeo: Quantum is great, I know lots of people from CMC and Hanna you should shoot me an email so I can send some recommendations, or send something out in an email

Hanna: We kind of want to change it so student performers that are djs can also perform. If students are performing something that is not original there may be copyright issues. It is open to any genre, we aren't trying to limit anything.

Amadeo: definitely excited to help.

Hanna is put in waiting room

Desmond: Let's fund \$300, worst case scenario, ASPC pockets the money. ASCMC will transfer money to ASPC, and ASPC will process the reimbursements.

Amadeo: Is there a way to see what other schools are funding? Because typically ASCMC gets the brunt of the costs. It would be great to see the other 5c equivalents to step up, especially because we don't have a bunch of CMC artists.



Desmond: I agree Deo, ASCMC overpays for everything 5c. We bankroll the 5c life. We buy a lot of goodwill for that. I think it is still a worthy thing. About \$100 dollars from other colleges adhoc, \$300 from their budget, and \$50-\$100 from the other schools
